collectively called and referred to as the "**TRUSTEES**" (which expression shall unless excluded by or repugnant to the context include the Trustees and each one of them for the time being and from time to time appointed and/or holding office under their presents and their survivor or survivors or successor or successors in office) of the **OTHER PART**

**WHEREAS** by a resolution passed at a meeting of the Members of the Settlor duly held and commenced at Diamond Residential Complex, Diamond Harbour Road, Dhankal, P.O. & Police Station - Bishnupur, in the District South 24 Parganas, Pin - 743503, it was resolved that the "Settlor" shall create a Trust with the aforesaid Trustees as the First Trustees for the objects hereinafter mentioned and for the benefit of the general public and to settle sum of Rs.1000/- (Rupees One Thousand) Only (hereinafter referred to as the "Said Resolution")

**WHEREAS THE TRUSTEES** have agreed to act as the First Trustees, **NOW THIS INDENTURE WITNESSETH AS FOLLOWS :-**

In pursuance of the said resolution and for the promotion of such Education, Relief to the Poor/Deserving Persons, Medical

- : ( 5 ) : -

Relief, Advancement of Education : Establishment of Good Schools, Colleges & Other Institute and other objects of general public utility as hereinafter mentioned the SETTLOR do hereby settle, transfer, assign and make over up to the TRUSTEES the sum of Rs. 1000/- TO THE SAME AND THE INVESTMENTS for the time being representing the same and other sums or properties that may from time to time form part of the Trust and the income, benefits and receipts therefrom up to the Trustees upon the Trust, and with and subject to the powers, provisions and declarations hereinafter contained and concerning the same which are as follows :-

1. NAME The name of the Trust shall be "**DIVYA ARYA VIDYA TRUST**". The Office of the Trust may be shifted as may be decided by its Trustees.
2. OBJECT The objects for which the TRUST FUND is established are Education, Relief to the Poor/ Deserving Persons, Medical Relief, Advancement of Education : Establishment of Good Schools, Colleges & Other Institute and advancement of any other education object of general public utility not involving the carrying on of any activity for profit.



- a) To acquire, establish, maintain and grant aid or other financial assistance to Schools, Libraries, Reading Rooms, Training Centre, and other establishments and Institutions for the development of education and diffusion of knowledge and for providing of employment.
- b) To organise debates, lectures, conferences and performances with a view to make the general public familiar with and to appreciate the qualitative trend of social, library and artistic thoughts.
- c) To grant and establish lectureships, scholarship, readerships, researches, prizes and other academic reward and also other aids, remuneration to students, teacher, artists, writers, technicians and other similar person or persons with a view to the advancement of literature, art, culture and knowledge.
- f. To promote physical, cultural and education of all children and adult and to assist or promote the arrangement of sports and games and generally to do all acts for the improvement and general health and physical development of persons of all ages.

- g) To do many other act for the advancement of general public utility not involving the carrying on of any activity for profit without distinction of caste, colour and creed.

**BOARD OF TRUSTEES**

3. The Trust shall be administered by a Board consisting of 7 Trustees. The First Trustees are :-

1. **MR. UMA SHANKAR PRASAD**, son of Late Mohan Sahu, by Faith - Hindu, by Occupation - Business, by Nationality - Indian, residing at 4A, "VIVEK VILLE", Opp. I I MC, P.O. & Police Station - Thakurpukur, Kolkata - 700104, in the District South 24 Parganas.

2. **MR. PANKAJ GUPTA**, son of Mr. Uma Shankar Prasad, by Faith - Hindu, by Occupation - Business, by Nationality - Indian, residing at 4A, "VIVEK VILLE", Opp. I I MC, P.O. Joka, Police Station - Thakurpukur, Kolkata - 700104, in the District South 24 Parganas.

3. **MR. DHARMENDAR GUPTA**, son of Late Panna Lal Gupta, by Faith - Hindu, by Occupation - Business, by Nationality - Indian, residing at Bijoyganj Bazar, P.O.



Ramnarayanpur, P.S. Mandir Bazar, in the District South 24 Parganas, Pin - 743336, West Bengal.

4. **MR. GOVIND PRASAD SINGH** son of Late Arun Kumar Singh, by Faith - Hindu, by Occupation - Business, by Nationality - Indian, residing at 38/16/7/3, New Vivekananda Park, Natunhat, Ramnagar, P.O. Raipur, P.S. Maheshtala, Kolkata - 700141.

5. **MR. RAMESH GUPTA**, son of Late Om Prakash Prasad, by Faith - Hindu, by Occupation - Business, by Nationality - Indian, residing at 49, Sishir Bhaduri Sarani, Khudiram Pally, P.O. & P.S. Siliguri, in the District Jalpaiguri, Pin - 734001.

6. **MR. MOUJILAL SHAW**, son of Late Jhari Shaw, by Faith - Hindu, by Occupation - Business, by Nationality - Indian, residing at 657/B, Thakurpukur Road, Napit Para, P.O. & P.S. Thakurpukur, Kolkata - 700063, in the District South 24 Parganas.

7. **MRS. SANDHYA DEVI**, wife of Late Bhola Prasad, daughter of Dhora Shaw, by Faith - Hindu, by Occupation - Business, by Nationality - Indian, residing at 102, Pathak

Para Road, P.O. Parnashree, P.S. Behala now Parnashree,  
Kolkata - 700060, in the District South 24 Parganas.

The First trustees and the trustees nominated for filling their vacancies shall be nominated Trustees. One of the nominated Trustees shall retire in any time in that event in his place Members of the Settlor shall nominate any other member of the Settlor to fill up Office of nominated Trustees. (The members of the Members of the Settlor shall also be members of the Board of Trustees).

The term of Office of the Members of the Settlor, who become members of the Board of Trustees, will be for one year commencing from 1st day of April to 31st March of each calendar year. The term of the trustee selected by the Settlor during the course of the term shall be for the residue of the said term provided.

5. a) The present Trustees shall be the First Trustees but shall within the period of Trust from the date hereof co-opt. the Members of the Settlor to the Trust Board.



6. *The Trustees shall not function if at any time their member is less than four save for the purpose of the appointing such member of Trustees as shall make up the deficiency.*
7. *In the event of any Trustees ceasing to be a Trustee, the remaining Trustees shall call upon the Settlor if it continues to exist at the material time, to nominate another Trustee in his place and the Settlor shall within a period of 3 (three) months of such request nominate a person to fill up the vacancy. In the event of the Settlor not complying with the requisition within the aforesaid period, the remaining Trustees shall be entitled to appoint any person to their choice to fill up the vacancy. Such Trustees for all purposes shall be regarded as Trustee nominated by the Settlor.*
8. *Before assuming office or taking part in any meeting, a newly appointed trustee shall give his consent in writing to act as such Trustee. A Trustee shall be deemed to have consented in case he attends any meeting of the Board of Trustees after being so nominated or appointed.*

9. Any Trustee may be one month's notice in writing to the Chairman and/or Settlor or all the other Trustees for the time being, retire from the office of a Trustee or any office held by him in respect of the trust and on the expiry of one month from the date of receipt of the notice, he shall cease to be a Trustee or hold the office as aforesaid.
10. A person shall cease to be Trustee in any of the following events :-
- i) If he/ she dies.
  - ii) If he/ she without leave of absence of the Board of Trustees remains absent from three meetings of the Board consecutively or six months, whichever is longer.
  - iii) If he/ she becomes insolvent.
  - iv) If he/ she becomes insane or otherwise incapable to act.
  - v) If he/ she retires or
  - vi) If he/ she goes permanently to reside out of India.
  - vii) If he/ she ceases to be a member of the Settlor.



11. MEETING AND RESOLUTIONS OF THE BOARD OF TRUSTEES :

- a) All meetings of the Board of Trustees will be held at such place as the Trustees may from time to time decide.
  - b) Notice of the meeting of the Trustees and all other communications may be sent to the Trustees at their respective address registered for the time being in the records of the Trust.
  - c) The Chairman or the Settlor may by a notice in writing convene a meeting of the Board of Trustees.
12. a) The Settlor of the Board will preside over all the meetings of the Board. In the absence of the Settlor shall preside and in the absence of the Settlor, the Trustees will choose one from amongst themselves to preside at such meeting.
- b) Any resolution in writing circulated amongst all the Trustees present in India and passed by a majority of three fourths of such Trustees shall be as valid and effectual as if it has been passed at a meeting of the Trustees only convened, a copy of such resolution after being passed shall be circulated to all the Trustees.

- c) All the Trustees shall be bound by the decision of the Board of Trustees whether in a meeting or by circular resolutions.

13. **TRUSTEES OFFICE AND VESTING OF PROPERTY :**

On a new Trustee being appointed and on his giving the consent as provided, the Trust property shall vest in him along with the other Trustees for the time being and he/she will be entitled to carry out all the duties and functions of the Trust as a Trustee and it shall not be necessary to make or execute any formal transfer of assets in his/her favour.

14. **FUND :**

- a) The fund and properties movable or immovable of the Trust shall vest in the Trustees holding office as such for the time being.
- b) The Trustees will keep such sum or sums of money as they consider proper in current or fixed deposit account in any of the Scheduled bank.
- c) Any Trustees authorised by the Board of Trustees may jointly operate and/or close any account of the Trust



- : ( 14 ) : -

*with any bank or bankers whatsoever and may sign and endorse cheques and withdraw interest or principal on any securities or any other investment made of the said funds, and give receipts, releases and discharges of the same.*

d) *As far as practicable, the fund of the Trust shall be spent for the objects and activities of the Settlor provided that the same are not inconsistent with and/or in contradiction with the object of the Trust.*

e) *The Trustees have agreed to become Trustees and to hold and apply the said sum of Rs.10,00,000/- (Rupees Ten Lakhs) Only and to give contributions, subscriptions and donations for the said fund and for such purposes and subject to the Trustees' Power and provisions contained in this Deed.*

15. *For the furtherance of the objects of the Trust, the Trustees will have the following powers :-*

i. *The Trustees may at any time receive any voluntary contribution or donation in cash or in kind from any member of from any member of the public or any firm, company,*

institution or association for all or any of the objects and purposes specified herein. As regards the terms and conditions of such donations and contributions the discretion of the Trustees shall be absolute and final.

- ii. The Trustees may invest the Trust Fund either in the purchase of immovable property, debentures, fixed deposits with banks and/or in such investments as are authorised by the Indian Trust Act., 1882 on such terms as to interest as the Trustees may think proper with power to the Trustees to alter, vary or transpose such investments from time to time in such manner as they may in their absolute discretion think fit. Provided, however, that the consent of the majority of the members of the trust for the time being present in the general meeting called for the purpose shall be required to purchase, sell, mortgage or charge immovable belonging to the Trust. Provided also that the corpus of the Trust may remain invested in shares of companies or loans due from firm or firms, individuals or or companies if the donations/subscriptions to the Trust has been made by the donor in the above form or forms.



- iii. *The Trustees may by the consent of majority of the Trustees for the time being raise or borrow money required for the purpose of the Trust on a mortgage or pledge of the Trust Estate or any part thereof with or without any security and at such rate of interest and on such terms as they shall in their absolute discretion think fit.*
- iv. *The Trustees may demise the immovable property or properties for the time being and from time to time belonging to the Trust either from year to year or for any less term or for any term of years or on monthly tenancies at such rate and subject to such covenants and terms as they proper and also accept surrenders of leases and tenancies and generally manage the same in such manner.*
- v. *The Trustees shall be at liberty to sell the whole or such portion or portions of the movable or immovable properties forming part of the Trust Estate either by public auction or by private contract at such price or prices and on such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to reject or vary any contract for the sale thereof and to re-sell the same*

without being answerable for any loss occasioned thereby for that purpose to execute all necessary conveyance, transfer or other assurance and to pass valid and effectual and discharges for all moneys received by them.

- vi. The Trustees may erect building, constructions and sheds of any material or design and may enter into contracts, execute all deeds and documents necessary for the same.
- vii. The Trustees may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the Trust Estate and may carry out repairs required to be done to the same and keep the same insured against loss or damages by fire or any other type of insurance risk, and pay all other costs charges and expenses of and incidental to the administration and management of the Trust Estate, the properties for the time being belonging to the Trust as they may in their absolute direction think fit.
- viii. The Trustees shall have full power to Institute, defend, prosecute, compromise or compound all actions suits and other proceedings and all differences and disputes touching the Trust Estate and/or the Trust properties and to refer any



such action, suits proceedings and differences relating to the Trust Estate and/or the Trust properties to arbitration and to do and execute all necessary acts, deeds, and things in that connection without being liable or answerable for any loss occasioned thereby.

ix. The Trustees may frame schemes and rules and regulations for the management and running of any institution established run or aided by them for managing the affairs of the Trust and otherwise for giving effects to the objects and purposes of the Trust and to vary the same from time to time.

x. The Trustees may appoint and dissolve committees and delegate such of its powers to the committees and/or sub-committees so appointed as they may in their discretion think fit. Persons who are not Trustees may also be member of such committees or sub-committees.

xi. The Trustees may employ servants, agents, attorneys, lawyers, teachers, auditors, officers, doctors, nurses and contractors for managing the affairs of and in furtherance of the objects of the Trust and pay them such salaries,

employment and bonus as the Trustees may in their sole discretion think fit.

xii. The Trustees shall have the right to purchase, take on lease or exchange or otherwise acquire land, building, houses or any other immovable or movable property and may lease or let out, or improve, manage, develop, exchange, mortgage, dispose of turn to account or otherwise settle or deal with any of such immovable or movable properties as the case may be and as the Trustees may consider proper and expedient.

xiii. The Trustees may open accounts with any Bank or Banks and operate such accounts and to give instructions to the Bank and to provide for opening, operation dealing and closing of such accounts by any two or more Trustees or by two or more agents appointed by the Trustees.

xiv. The Trust created hereby is irrevocable.

xv. The Trustees for the purposes aforesaid to found, maintain, organise, run, manage, supervise, superintend, affiliate, control, guide and aid pathsalas, Schools, Colleges and other academic institutions including Laboratories, Libraries,

Lecture Halls, Practical Classes and other educational institute and institute for aswareness towards preservation of human culture and Socio-Economical Development and also psychology and philosophical studies and institute for work on humanity and mankind.

xvi. To hold examinations and to grant certificate of proficiency or other academic distinction or title to persons who have complied with the conditions laid down in the regulations or by-laws of the Trust including Rules and Regulations of the State Govt. or any other statutory body set up by such Govt. including rules and by-laws of CISCE, CBSE, West Bengal Board of other Boards etc. as would be applicable depending upon the nature of Institute and its affiliation.

xvii. Establishing, maintaining and/or granting aid to institutions for the relief of the poor and advancement of the education and also for the purpose of aforesaid to grant periodical and other occasional purposes of aforesaid, also to deserving persons as the Trustees may thnik fit and proper.

xviii. To establish old age home for maintenance, fooding, lodging to its Boarders or resident of old age home and to take care



of their health and to arrange for their treatment during their illness.

xix. To give aid to institute, working for doing welfare and other development of humanity and mankind.

xx. Educational institutions of all levels standard and course encourage, literature, arts, medicine, science, agriculture crafts, history, technology, agriculture technology and technical education in all branches.

xxi. Endowment to different universities existing or which may hereafter come into existence for the purpose of encouraging education.

xxii. To pay tuition fees, examinations fees, boarding and lodging fees to deserving students and to supply books free of cost to such students.

xxiii. To make monthly or other periodical or lump-sum grants and contributions for the advancement of education of educational institutions.

xxiv. To render financial help to deserving students to enable them to purchase books and other equipment's necessary for their education.

xxv. To establish or to aid school, colleges for adult education and general awareness to the poor downtrodden, illiterate persons irrespective of caste, creed, sex, religion.

xxvi. To give education and/or aid to the existing school as the Trustees may deem fit and proper.

xxvii. Establishing or rendered help to any institutions for the alleviation of human sufferings.

xxviii. To distribute blankets, rages, woolen clothing's clothes or cotton, woolen silken and other varieties of clothes to the needy.

xix. To start, maintain and assist any relief measures in those parts which are subject to natural calamities, like famine, fire, flood, dearth of water, earthquake etc.

16. To establish promote printing press and to print, publish, sell Text book of Schools, Colleges or other Newspapers, Magazines, Periodicals, Research Papers and other matters or materials of general importance and to sell the same and purchase new materials and other things or materials and to publish any magazine, news weekly, daily or monthly and

to sell the same at such price as the Trustees may deem fit and proper.

17. To help or to grant aid to such person or persons including other religious, social and economical institute as the Trustees may deem fit and proper at their discretion.
18. To carry on any business for the benefit and for augmenting the income of the Trust and to utilise the same for the object of the Trust and to do all acts, deeds and things as may expected to be done by the Management of the business in its normal or usual course.
19. To do social welfare and to propagate Indian Culture amongst the general public and to do all acts, deeds and things as may be necessary for social welfare, harrmony in community, euducational development and other advancement and/or improvement of general public at large and for uplifting of their mental attitude.
20. It is expressly declared that no part of the Trust property or its income shall be applied out of India or for any purpose which is not a public charitable purpose in law and all provisions hereof shall be constructed accordingly.
